Supervisor's Report

1. Supervisor Watkins Stated that everyone will be involved in these Town Board meetings there will be something new on the agenda every month, next month Dieter Drake will make a presentation on the Bicycle Race in Cambridge, Steve Robinson will also be contacted to speak.
2. Supervisor Watkins requested that Ashleigh Farrell put in The Eagle Exemptions must be in 1st of March to the Assessor this includes Ag, Star, and Veterans.
3. Thursdays the 1st and the 3rd of the month Supervisor Watkins will have office hours at the Town Hall from 5:00 to 7:00 PM. This will be the Thursday before the Planning Board Meeting and the Thursday before the Town Board Meeting any problems in the town can be brought forward to Supervisor Watkins at this time.
4. The Assessor's hours will also be on Thursdays from 11:00 AM – 7:00 PM.
5. Supervisor Watkins appointed Councilwoman Fedler as his Deputy Supervisor and Sandra Davis as his Historian this is stated in the Organizational Resolution, this appointment can be made by the supervisor without the authorization of the Town Board.
6. When the bills are audited this information will be made available to the public, the taxpayers will know how their money is being spent.
7. The New York State General Municipal Law, Section 800-809 Conflicts of Interest of Municipal Officers and Employees was posted in the Town Hall and also inside the Highway

Garage. Copies of the Town of Cambridge Procurement Policy and Code of Ethics were given to each Town Board member and will be reviewed at the next meeting.

8. Supervisor Watkins stated that Councilman Davis is working on a project, getting dependable internet for the Town Hall, he has tried the Verizon wireless air card at the Town Hall but not sure of volume of data transfer and how much it is going to cost for the Town Hall because of the mega bytes needed when reporting information. Councilman Davis reported this to cost him \$60.00 a month, Councilman Berndt stated that the fee for Wildblue is a \$50.00 installation fee and would be \$50.00 monthly.

Resolved that the Town Clerk be granted the right to use her discretion to secure a High Speed Internet Vendor for the Town Hall.

In regards to High Speed Internet (DSL) in the Town of Cambridge, Supervisor Watkins has spoken to Assemblyman Tony Jordan and also stated that he had written a letter that the Town Hall was being discriminated against because it was being denied DSL access. He forwarded a letter to Senator Betty Little's office. Councilman Berndt made the Supervisor aware that the Town of Cambridge does have a Community High Speed Internet Committee and he named several members and their qualifications to serve. Mr. Berndt hopes that we would stay in the confines of this committee, Supervisor Watkins states that is fine that Cliff DeCarlo is the person that he spoke to and Mr. Watkins concern is to get high speed internet for the Town Hall. Others present from the community made comments and suggestions concerning the internet providers mentioned.

Town Board Report

Councilman Berndt reported that he attended two meetings one on Internet Safety by Sr. with Attorney General Office, Investigator Casey Quin mostly on internet safety for Elementary and middle school and also a Tour Battenkill Technical meeting and they would like to get on the agenda for the February meeting, Supervisor Watkins has already spoken to Dieter Drake and he will be on the that agenda.

Councilman Berndt has updated the website for the town with all newly elected officials he will post Supervisors Watkins hours on the site.

Councilman Berndt also stated that there was a new website Real Property Services the real tax rate and graft shows all the townships, municipalites, villages, all units, school districts, sewer districts and it shows that the Town of Cambridge is in the lower third for taxes some said in November that the Town of Cambridge has the second or third highest taxes in the county. Rani Bass questioned this and Councilman Berndt asked her to submit this information to the Board.

Councilman Berndt under New Business would like to add Procurement and Investments policies which he will bring up later in the meeting.

Planning Board

In Planning Board Secretaries Eddy's absence, Town Clerk Heather Greenawalt read her report aloud.

The Planning Board met Thursday, January 7, with a full board present. They addressed one item of business.

Gerald Moppert presented a survey map showing a boundary line adjustment between his property and an adjacent property on Irish Lane. It involved a miniscule amount of property. Each property owner gained a little and both landowners came to a mutual agreement.

The Planning Board determined the action did not fit the definition of a subdivision and voted to categorize it a boundary line adjustment.

Superintendent of Highways

1. They dealt with a number of snow storms and only minor breakdowns.
2. Last month three of the highway men were tested for drugs and alcohol under the Random Drug and Alcohol Testing requirements.
3. After the weekend storm we helped the Village of Cambridge pick snow for one day.
4. Cutting edges were changed on the loader and the plow on the 1988 truck.
5. The trucks were cleaned and greased between storms.

Unfinished Business

Organizational Resolution

The 2010 Organizational Resolution was read by Town Clerk Heather Greenawalt aloud and any questions and concerns were discussed. Margaret Shaw Clerk to the Supervisor stated that corrections to the Resolution were as follows change in Salary of Deputy Supervisor to \$25 per diem as stated earlier in Resolution #7 and the Budget Officer salary was changed to none.

Resolution #9

Councilman Berndt motioned, seconded by Councilwoman Fedler, to approve the clerk to the Justice salary of \$1,200 as stated in the Organizational Resolution and

WHEREAS, a budget amendment is needed to increase the Justice Personal Services account line item A1110.1. It has been proposed that the position of Justice and Clerk to the justice need to be accounted for in separate line items. It has also been recommended by our current justice that the salary of Justice be established at \$3,000 and Clerk to the Justice at \$1,200.

THEREFORE, Due to the fact the Supervisor/Budget Officer has waived his salary, a transfer could be made from the Budget Officer Personal Services line item (A1340.1) in the amount of \$700 to the Justice Personal Services account (A1110.1). Two separate lines items, both coded A1110.1, can be established, specifying the separate positions.
